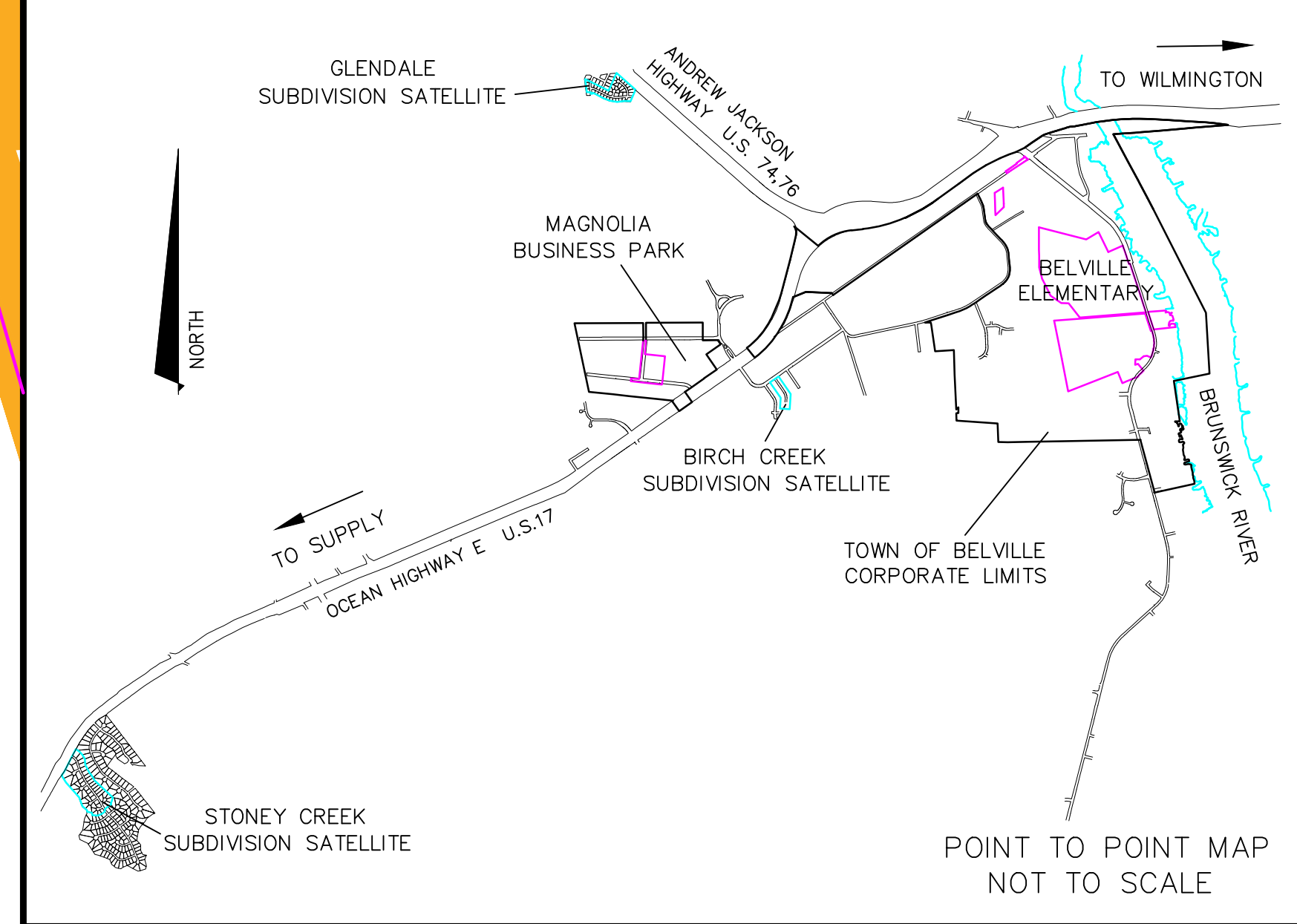


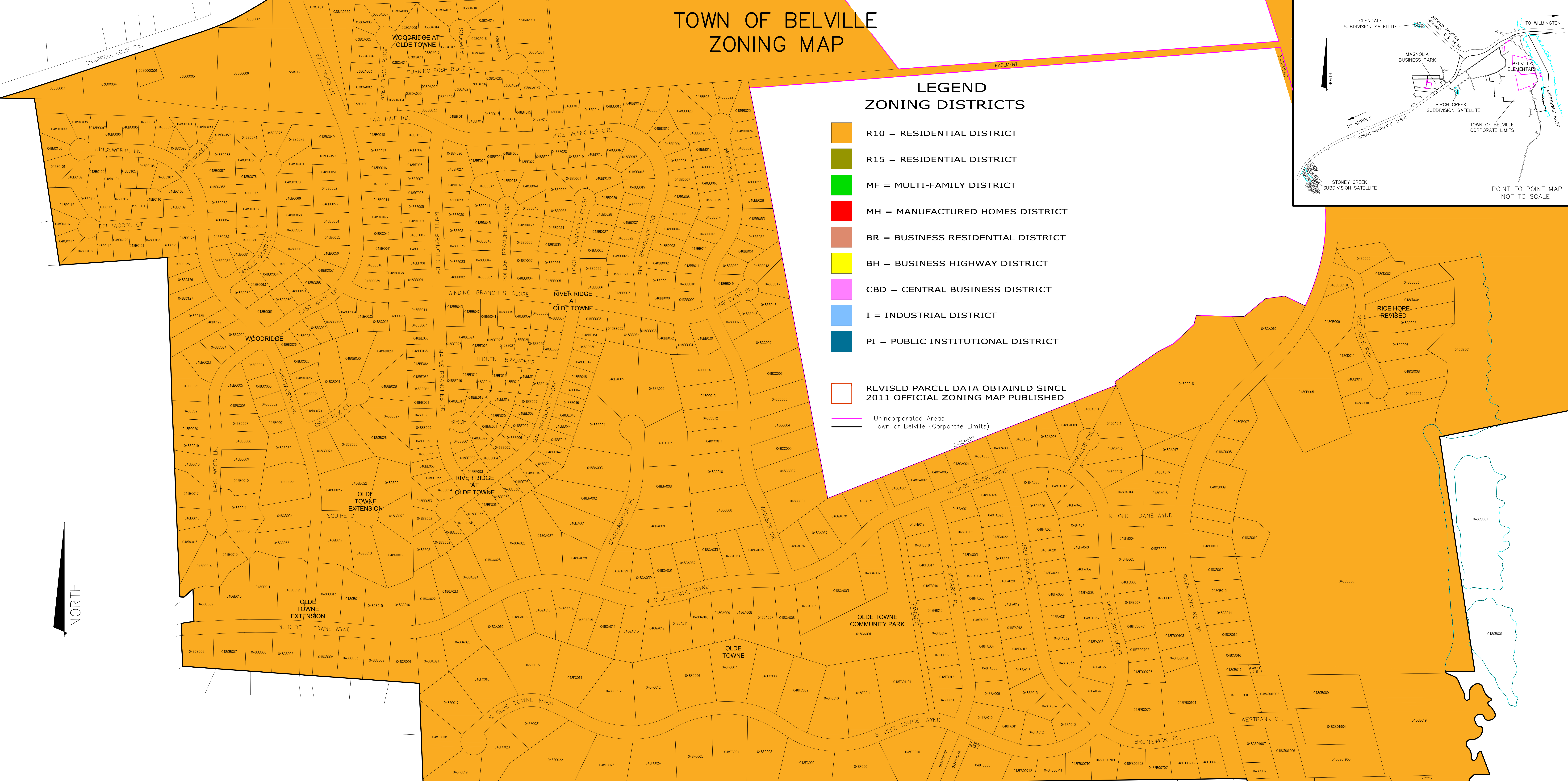
TOWN OF BELVILLE ZONING MAP
