The Planning Board shall continue in its present form and function.

The rules governing the Planning Board's proceedings shall be as provided for in Town Ordinance No. 64, as amended from time to time.

Section 8.2.3 Function and Duties

In addition to any authority, functions, duties and responsibilities which are prescribed by the General Statutes, the Planning Board is hereby vested with the following functions and duties:

1. Review and comment on, for the Board's consideration and action thereon, a zoning

- ordinance, zoning map, regulations for the subdivision of land, any amendments to the foregoing, including rezoning applications, and any other land use and/or development regulations deemed appropriate and as directed by the Board.
- 2. Review and comment on, for the Board's consideration and action thereon, master development plans, and any of the specified amendments thereto, in accordance with the provisions of Article 7, *Overlay Districts*, Section 7.2.5, *Master Development Plan*.
- 3. Review and comment on, for the Board's consideration and action thereon, applications for special use permits in accordance with the provisions of Article 9, *Review and Approval Procedures*, Section 9.4, *Special Uses*.
- 4. Review and approve subdivision plats in accordance with the Town's Subdivision and Commercial Regulations.

The Planning Board is hereby designated to set, as a Board of Adjustment, for the purpose of performing the duties set forth in Section 8.3.2 herein.

Section 8.3.2 Functions and Duties

In addition to any authority, functions, duties and responsibilities which are prescribed by the General Statutes, the Board of Adjustment is hereby vested with the following functions and duties:

- 1. Hear and decide upon variance applications in accordance with the provisions of Article 9, *Review and Approval Procedures*, Section 9.7, *Variances and Appeals*.
- 2. Hear and decide upon appeals from and review of any order, requirement, decision or determination made by an administrative official charged with the enforcement of this Ordinance in accordance with the provisions of Article 9, *Review and Approval Procedures*, Section 9.7, *Variances and Appeals*.
- 3. Interpret zoning maps and pass upon disputed questions of lot lines or district/overlay boundary lines provided, however, that such interpretations and questions are first presented to the Town Manager for possible resolution thereof.
- 4. Subpoening witnesses and compelling the production of evidence. If a person fails or refuses to obey any such subpoena, the Board of Adjustment may apply to the General Court of Justice for an order requiring that the subpoena be obeyed.
